(1) The ordinary share with par value of HK\$0.01 each in the share capital of the Company (the “Shares”) were listed on the Main Board of The Stock Exchange of Hong Kong Limited on 11 July 2014.

(2) The Company adopted a Pre-IPO share option scheme on 24 June 2014 and effective on 11 July 2014 (the “Pre-IPO Share Option Scheme”), pursuant to which options have been granted to certain eligible participants to subscribe for a total of 2,319,659 Shares at an exercise price of HK\$2.40 per Share. These options are exercisable between 11 July 2014 and 11 July 2016.

(3) Pursuant to the Pre-IPO Share Option Scheme, the Company has granted options to certain eligible participants to subscribe for a total of 4,501,680 Shares at an exercise price of HK\$3.00 per Share. These options are exercisable between 11 July 2015 and 11 July 2017.

(4) The over-allotment option exercisable by BOCI Asia Limited granted by the Company under the International Underwriting Agreement (as defined in the prospectus of the Company dated 30 June 2014) will not be exercised. For details, please refer to the announcement of the Company dated 10 July 2014.
