(1) The Company adopted a pre-IPO share option scheme (the "Scheme") on 24 June 2014, which became effective on 11 July 2014. Pursuant to the Scheme, options have been granted to certain eligible participants to subscribe for a total of 2,319,659 ordinary shares of the Company (the "Shares") at an exercise price of HK\$2.40 per Share. These options are exercisable between 11 July 2014 and 11 July 2016.

(2) Pursuant to the Scheme, the Company has granted options to certain eligible participants to subscribe for a total of 4,501,680 Shares at an exercise price of HK\$3.00 per Share. These options are exercisable between 11 July 2015 and 11 July 2017.
